DIRECTIONS TO WHITE PLAINS OFFICE

ON ENTERING HTA HEALTHCARE TRUST OF AMERICA, 222 IS THE LARGE BUILDING IN THE REAR. PARKING IS ACCESSED FROM THE RAMP TO THE LEFT OF THE BUILDING.

From the East: (Connecticut and Interstate 95)

- I 287 West to Exit 9N-S. This exits onto Westchester Ave. westbound. Follow for approximately 2 ¼ miles. **HTA Healthcare Trust of America, #222 Westchester Ave.** is on the right.

From the West: (Tappan Zee Bridge and Tarrytown)

- I 287 East to Exit 8E. Follow signs for Westchester Ave. Proceed to the second traffic light and make left turn over the W.M.L. Butcher Bridge. Turn left again onto Westchester Ave. westbound. **HTA Healthcare Trust of America, #222 Westchester Ave.** is on the right.

From the South:

- Saw Mill River Parkway or Sprain Brook Parkway to I 287 East to Exit 8E. Follow above directions from West.
- Hutchinson River Parkway North to Exit 26W. This exits onto Westchester Ave. Stay on Westchester Ave. for 1 ¼ miles. **HTA Healthcare Trust of America, #222 Westchester Ave.** is on the right.

From the North:

- I 684 South to Westchester Ave. White Plains Exit. Stay to the far right and follow signs to Westchester Ave. Follow Westchester Ave. for approximately ½ mile. **HTA Healthcare Trust of America, #222 Westchester Ave.** is on the right.
- Merritt Parkway to Hutchinson River Parkway S to exit 26W. This exits onto Westchester Ave. Stay on Westchester Ave. for 1 ¼ miles. **HTA Healthcare Trust of America, #222 Westchester Ave.** is on the right.

From Downtown White Plains:

- With the Westchester Mall on your right, follow Westchester Avenue Eastbound towards I 287. Follow signs for Westchester Ave. Proceed to the second traffic light and make a left over W.M.L. Butcher Bridge. Turn left again onto Westchester Ave. westbound. **HTA Healthcare Trust of America, #222 Westchester Ave.** is on the right.

DIRECTIONS TO MT. KISCO OFFICE

OUR OFFICE IS LOCATED AT 359 EAST MAIN STREET IN THE CENTER OF MT. KISCO, OPPOSITE THE HOSPITAL AND NEXT TO THE BOYS AND GIRLS CLUB.

From the South:

- I-684 North to exit 4 (Mt. Kisco-Route172). Turn left on 172 and follow into Mt. Kisco. At the end of 172 turn right onto Main St., 359 E. Main Street is second building on the right.
- Saw Mill River Pkwy. North to Reader's Digest Road (exit 33). Bear right up the hill to light. Turn left onto 117 North. Continue 2 miles into Mt. Kisco. 359 E. Main St. is on the right opposite the hospital.

From the North:

- I-684 South to exit 4 (Mt. Kisco-Route 172). Turn right onto 172 and follow into Mt. Kisco. At end turn right onto Main Street. 359 E. Main St. is second building on the right.
- Saw Mill River Pkwy. South to exit 37 (Kisco Ave.). Left at stop onto Kisco Ave. to 2nd light. Left onto Main St. for 1 mile. 359 E. Main St. is on the left opposite the hospital.
